1. OPEN MEETING WITH INVOCATION AND PLEDGE

Mayor Fisher called the formal session open. Council member Jackson gave the invocation and all joined in the pledge.

2. RECOGNITION OF VISITORS

6. PRESENTATION OF ANNUAL RACIAL PROFILING REPORT

Chief Smith presented council with the Annual Racial Profiling Report. This data is required by law to be presented to council annually. The report shows what data has to be presented and is mandated by law. There were 1865 traffic stops with 1632 stops resulting in citations for the Crockett Police Department for the year. The report shows no racial profiling in the City of Crockett.

7. FIRE DEPARTMENT MONTHLY ACTIVITY AND STATUS REPORT FOR JANUARY 2021

Fire Chief Frizzell reported for the month of January the following: 91 total calls. A breakdown is included in the packets.

8. CONSIDER AND APPROVE A RESOLUTION AND AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE TEMPORARY CLOSURE OF STATE RIGHT OF WAY FOR ANNUAL DAVY CROCKETT FESTIVAL
